Directions:

Coming from the North, take the Turnpike Exit off 101 (between Goleta and Santa Barbara). Turn left off the ramp onto Turnpike Road. Get in the right lane. After crossing the freeway, turn right onto Calle Real. Camino del Remedio is on the left within a half mile. Turn left, and take your first left into the parking lot. The Employee's University building is at the back of the parking lot facing the freeway.

Coming from the South, take the El Sueno Exit off 101, one or two exits after the 154 and State Street Exit. The Exit leads to a stop sign intersection with Calle Real. Turn left on Calle Real. Camino del Remedio is on the right within  $\frac{3}{4}$  of a mile. Turn right, and take your first left into the parking lot. The Employee's University building is at the back of the parking lot facing the freeway.
